Fixed assets are stated at cost of acquisition or revaluation made during the period less accumulated depreciation

5 DEPRECIATION:

Depreciation on Fixed assets is provided on Written Down Value Method in the manner and the rates prescribed in the Income tax. Act, 1961.

6 ADMINISTRATION EXPENSES:

administrative expenses have been shown directly in the Income and Expenditure Account as CBTC does not have permanent staff nor it has its own source of income for incurring expenses. The Administration expenses for the year has been distributed among the different projects on the basis of the activities of the different projects.
