

Notice Inviting Tender

The North East Cane and Bamboo Development Council (NECBDC), a society under the North Eastern Council, Ministry of Development of North Eastern Region (MDoNER), Government of India, invites online bids (e-tenders) under a Single Stage, Two Cover system from eligible, licensed and financially sound manufacturers, importers, wholesale dealers and authorised suppliers of fertilisers, for the supply of Urea, Single Super Phosphate (SSP) and Muriate of Potash (MOP), on Rate Contract basis, at designated bamboo plantation sites located in various blocks of Karbi Anglong district of Assam and Mokokchung and Chumoukedima districts of Nagaland.
