

## Notice Inviting Tender

The North East Cane and Bamboo Development Council (NECBDC), a society under the North Eastern Council, Ministry of Development of North Eastern Region (MDoNER), Government of India, invites online bids (e-tenders) under a Single Stage, Two Cover system from accredited bamboo nurseries and eligible, experienced and financially sound suppliers of quality bamboo planting material, for the supply of bamboo saplings, on Rate Contract basis, at designated bamboo plantation sites located in various blocks of Karbi Anglong district of Assam and Mokokchung and Chumoukedima districts of Nagaland.
